ASEAN-AUSTRALIA CENTRE

The ASEAN-Australia Centre (the Centre) was announced by the Prime Minister of Australia at the ASEAN-Australia Special Summit in March 2024. Operational since 1 July 2024, the Centre implements key recommendations from *Invested: Australia's Southeast Asia Economic Strategy to 2040* to promote greater Southeast Asia literacy in Australia. The Centre delivers initiatives that strengthens business, education, cultural and community connections between Australia and ASEAN member states.

The goal of the ASEAN-Australia Centre Leadership Program is to build a network of future ASEAN leaders with strong connections to Australia, who will drive positive change across Australia and Southeast Asia.

THE SHORT COURSE

The *ASEAN's Digital Transformation: Balancing Innovation, Integrity and Inclusion* short course will strengthen the capacity of 24 emerging and mid-career female leaders from ASEAN member states and Australia to navigate the opportunities and risks of digital transformation, with a focus on AI, Big Tech influence and youth well-being.

The short course will be delivered over up to 12 weeks in the first half of 2026, through a blend of online learning and a one-week immersion program in Australia.

Through policy dialogue, applied learning, and engagement with Australian experts, participants will explore how to design and implement frameworks that harness digital technologies for growth and inclusion—while safeguarding societies against misinformation, exploitation, and inequitable digital power structures.

OBJECTIVES

The short course will support participants to:

- analyse the growth trajectory and structural dynamics of ASEAN's digital economy, including the role of AI, platform ecosystems, and data-driven business models
- evaluate the societal, economic, and ethical implications of Artificial Intelligence and Big Tech dominance
- assess the risks and consequences of misinformation and disinformation and review ASEAN and Australian strategies for building information integrity and public trust
- examine policies and frameworks that support responsible AI, digital rights, and youth protection in online environments, identifying shared lessons across ASEAN and Australia
- explore innovations and practical tools for digital literacy, critical thinking, and ethical technology design, empowering young people and communities to engage safely and effectively online
- identify opportunities for regional cooperation and investment in digital innovation, data governance, and cross-border interoperability
- develop actionable strategies or policy recommendations to strengthen digital resilience, inclusion, and accountability, ensuring that digital transformation benefits all sectors of society.

BENEFITS

Short course participants will receive:

- a program of stimulating and interactive sessions delivered by expert facilitators
- a return airfare, accommodation, transport and meals for the in-Australia component
- pre-departure information and virtual briefing
- a tailored in-Australia program of learning, networking and cultural experiences
- 24/7 in-Australia support through a dedicated Welfare Officer.

All applications must include a:

- completed application form
- curriculum vitae (CV)
- current employer referee report in the template provided [here](#).
- a certified copy of bachelor's degree.

For Southeast Asian applicants only:

- a copy of their passport ID page
- evidence of working proficiency in English if available (e.g. English language test or evidence of undergraduate studies undertaken in English)

Shortlisted applicants will be invited to attend an online interview in early-mid December 2025.

ELIGIBILITY CRITERIA

All prospective applicants must adhere to the following eligibility requirements:

- submission of a complete application including all relevant documents
- commitment to full attendance throughout the program including the in-Australia immersion week
- be a citizen of and residing in Australia, Brunei, Cambodia, Indonesia, Laos, Malaysia, Myanmar*, the Philippines, Singapore, Thailand, Vietnam or Timor-Leste (*Residency requirement does not apply to Myanmar citizens)
- hold a bachelor's degree or equivalent.

Southeast Asia applicants must also adhere to the following eligibility requirements:

- professional working proficiency in English (recommended at least IELTS 6.5)
- hold a valid passport that meets Australian immigration requirements.

Applications are strongly encouraged from women, people with disability and other marginalised groups

ASSESSMENT

Applicants will be assessed on the following criteria:

- early-to-mid-career female professional with between five- and ten-years' work experience related to digital technology and transformation
- demonstrated commitment to building networks and leading digital transformation in their sector.
